**-OTHER ATTENDANCE REGULATIONS-**

- Military Collectors Vehicles, Show Bikes & Cars may Park & Display Free (although if vending/selling or advertising your business you will need to pay for at least one space; No exceptions please).
- Non Profit & Charitable Organizations may apply for free or discounted space.
- Food & Drink Vendor (special requirements may apply, please inquire).
- No Generators may be used on site without prior notice and acceptance.
- Electrical power can be provided in some cases, you must inquire in advance for this service (minimum power charge of \$25.00 per 20 amp breaker).

**-STATEMENT OF POLICY-**

1. This agreement is by and between the Vendor and J&S Surplus a division of Eagle Emblems Inc.
2. Booths cannot be divided or resold. Violators of these rules will not be invited to participate in future shows.
3. All checks are payable to: J&S Surplus (If the bank does not honor your check your reservation will be canceled).
4. All Vendors are required to have a valid California Resale Number, and are responsible for collecting and reporting their own sales and taxes.
5. Vendor must furnish own props, e.g. tables, chairs, etc.
6. Vendor Setup opens at 6:30AM the day of the event and vendors must be checked in no later than 9:00AM with J&S Surplus officials.
7. Vendors should remain until 5:00PM and vacate by approx. 7:00PM.
8. Vending spaces do not allow for vehicles (unless it is part of your display, i.e. collector vehicle, etc) Vendor vehicles must be parked in the customer parking lot by 9:00AM unless you have registered to have your vehicle be a part of your booth.
9. Sales theme is Military Merchandise, Military Antiques & Collectibles, Collectors Vehicles, Biker Apparel & Similar goods.
10. Vendors must leave their area clean and trash free.
11. Pets are welcome but must remain in your booth or vehicle. Dogs to be kept on a leash and are not allowed on the streets or driveways and must not be allowed to disturb vendors or customers.
12. Vendor agrees that J&S Surplus & Eagle Iron divisions of Eagle Emblems Inc. and staff will not be held responsible for any lost, stolen or damaged materials, merchandise and/or property.
13. Vendor agrees that J&S Surplus & Eagle Iron divisions of Eagle Emblems Inc. and staff will not be held responsible for any loss caused by rain, cold, fog or any other elements of nature.
